She noted an extraordinary maintenance chart detailing the vacancy initiative amounts and the budget revision the board approved in November. She also stated that the fire alarm control panel shows the values of the River Street fire panel emergency project, which she hopes will also be reimbursed by the state as a capital project.

E.D. Sullivan Noted the fire damage from the report and explained it was smoke damage, a stovetop fire, no injuries, and no need to replace the cabinets. Pet policy has been mailed to all residents in English and whatever their





written language is. The 2024 CIP has been approved, and we are working towards a revision for the ARPA Earmark projects. We have about nine projects that have a FISH number.

7. Chairpersons Report- Chairperson Sanchez was excited that the WHA main office had decorations for Hanukkah and showed that we are an inclusion housing development. With so many residents from different cultural backgrounds, seeing the housing authority recognize that was nice. Chairperson Sanchez thanked Kids Backing Kids, Mitten Giving Tree, Wellesley Fire Department, and Wellesley Police Department for their partnership during the holiday season. Executive Director Sullivan stated we sponsored about 42 residents, which doubled from last holiday season.

Commissioner Coduri connected with Margaret Moran of Cambridge Housing Authority and hopes to meet after the New Year to discuss the cost of the proposal she provided. Hopefully, Commissioner Coduri can bring it to the board for discussion.

ED Sullivan provided the board with references and a recommendation from Gwen C. Erskine, RA, GCE Architecture. She is the individual who does the reference checks for the bidding process for this job. Northeast Construction had an overall theme from the reference check- the project was slow, responding to the punch list was difficult and slow, and communication was poor. Northeast Construction has mixed recommendations, and Gwen's direct experience with them was not positive. Northeast Construction is currently not qualified for this project.
