Board went through the draft management agreement section by section - the document was prepared by Commissioner Renzella. Commissioner Renzella shared with the Board that after consulting with the Wellesley HA fee accountant and after careful consideration the best option though not ideal is to enter into a management agreement with Watertown. This will ensure the stability of Wellesley HA, while giving the Board time to consider what is best for Wellesley HA. Commissioner Renzella stated that the ED of Watertown prefers the chain of command and at this point, all materials related to the agreement and the search will be transferred over to Odessa Sanchez, Chair. Chair Sanchez will be the point of contact moving forward on the Wellesley HA transition.
